



LABOR:

The total labor force of Andrews is 7,114. 6,684 are employed. The Andrews Unemployment rate is 6.0%.

TRANSPORTATION:

Andrews is the County Seat of Andrews County located on east-west highway State 176; north-south highway U.S. 385, and northeast-southwest highway State 115. Interstate 20 is also easily accessible by multiple routes. The Andrews County Airport offers three runways; the longest is 5,815 feet and lighted. Self-service fuel and instrument landing system available. Commercial airline service is available at nearby Midland International Airport (37 miles, 560,000 boardings per year). Freight carriers serving Andrews include Central Freight, Airborne Express, DHL, UPS and Federal Express (Fed-Ex).

GENERAL:

- MEDICAL:** One 49-bed county hospital, state-of-the-art emergency rooms, 90-bed long-term care facility, 12 doctors, 4 dentists, two optometrists, and two pharmacists.
- EDUCATION:** Texas Education Agency "Recognized" district. Three elementary schools, one renovated middle school, and a renovated high school, which features the recently constructed Andrews Performance Center.
- HIGHER EDUCATION:** Andrews Business & Technology Center. Odessa College, (27 mi.) UT-Permian Basin (27 mi.)
- MOTELS:** Five motels with 200 rooms and 1 bed and breakfast. Rooms for extended stays are available at three of the five motels
- BANKS:** Two banks with total deposits of \$117,000,000.
- CREDIT UNIONS:** One credit union with \$5,970,000 in total deposits.
- NEWS MEDIA:** One bi-weekly newspaper; one radio station.
